Cats: Current HCP\FVRCP Feline Leukemia & Rabies.

All Pets: Flea\Parasite Control

My pet(s) receive monthly flea and tick prevention from their Vet. _____

I agree that my pet will enter FFBB clean, without fleas and/or other parasites. I further authorize and agree to pay FFBB to administer Capstar and to perform a Flea and Tick Bath upon entry if it deems necessary. _____ (initial)

If my pet becomes ill or if the state of my pet's health otherwise requires professional services, I authorize FFBB, in its sole discretion, to engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses for this care shall be paid by me. I further hold FFBB harmless for any accidental injury and/or illness my pet may incur while under its care.
